7. UNDERTAKINGS

> To carry on professional activities within a joint-stock company or a limited liability partnership:

7.1 I (We) undertake to:

- Make the present declaration accompanied by the fees of \$100 + taxes (5% and 9.5%) = \$114.98;
- Provide a document certifying that the partnership or company is covered by security against the professional misconduct of its members in compliance with Division II of the regulation. Pursuant to paragraph g) of section 93 of the Professional Code, the coverage must extend to any claim filed against the partnership or company during the five years following the year members who carry on professional activities within a partnership or company decease, leave the partnership or company or cease to be members of the professional order, such as to maintain coverage, on behalf of the partnership or company, against liabilities arising from fault or negligence in the practice of their profession within the partnership or company;
- Provide, in the case of a joint-stock company, a copy of its constituting act and a document issued by the competent authority certifying that the company exists;
- Provide a document issued by the competent authority certifying that the partnership or company is duly registered in Québec;
- Provide an authorization from the partnership or company allowing a person, committee, council or tribunal referred to in section 192 of the Professional Code to require disclosure of and obtain any document listed in section 11 from a person or to obtain a true copy of such a document;
- Provide, if applicable, a true copy of the declaration required under the Act respecting the legal publicity of sole proprietorships, partnerships and legal persons (R.S.Q., c. P-45), stating that the general partnership has become a limited liability partnership.

> To maintain the right to carry on professional activities within a partnership or company:

7.2 I (We) undertake to:

- Update and provide, before March 31 of each year, the declaration prescribed in section 4 of the regulation;
- Promptly notify the secretary of the Order of any change in the security prescribed for the partnership or company against the professional misconduct of its members in Division II of the regulation or in the information given under section 4 of the regulation which would entail a violation of the conditions set out in section 2 or 3 of the regulation;
- Cease carrying on professional activities within the partnership or company if the necessary measures to comply have not been taken within 15 days after becoming aware that a condition set out in the regulation or in chapter VI.3 of the Professional Code is no longer met.
